# LANGUAGE TRAINING WITH KERN AG TRAINING

### TERMS AND CONDITIONS FOR LANGUAGE COURSE PARTICIPATION

#### § 1 CONTRACT

With the completion of the registration form, the customer enters into a binding contract with the training provider for the purpose of language training. The customer may only complete the registration in writing. The contract is concluded by the acceptance of the training provider. The acceptance need not take on a specific form. The training provider will send a confirmation of the reservation to specify the services to be provided.

#### § 2 TERMS OF PAYMENT

The tuition fees are net prices and are payable prior to the commencement of the training or upon receipt of the invoice, in cash or by debit order, unless otherwise agreed in writing. Any additional services and the required learning material (course and work books/CDs) will be invoiced separately in accordance with the book trade price and will be charged automatically by debit order. Payments made are irrevocable and non-refundable. The customer will ensure that he/she has sufficient funds in his/her current account. The customer will inform the training provider immediately of any changes in his/her bank details by submitting an amended debit order. Barring the assertion of additional damages, if payment is in default or if payment is revoked, the customer will be charged a fee of 25 euros for default interest and administrative fees, plus any accrued back-posting fees, to be paid in cash immediately. The training provider maintains the right to cancel the customer's right to pay by debit order immediately. In the event of a late payment, the training provider is entitled to rescind the training contract / registration and to terminate further training with immediate effect.

#### § 3 SERVICES PROVIDED BY THE TRAINING PROVIDER

The extent of the contractual services will result from the service description of the training provider, as well as from the details set forth in the confirmation of reservation. Additional agreements, which alter the extent of the contractual services, will require formal confirmation in writing. The language training course will be taught by a language coach. Based on prior coordination, the lessons can take place in an actual or virtual classroom. The regulations of these General Terms and Conditions apply equally to both forms of teaching. The language training provided will correspond to the number of sessions agreed upon in the booking confirmation. One single lesson amounts up to 45 minutes and one day of sessions amounts up to 8 single lessons. The training provider, however, reserves the right to employ another trainer. Such a change of trainer is not deemed to be a rescission or breach of contract or to permit a reduction in tuition fees. Should a trainer cancel on short notice, the training provider will take reasonable steps to provide another trainer at the earliest possible date. Should the agreed upon intensive training ses-

sions be cancelled or postponed within two weeks prior to the commencement of the training, a cancellation fee of 50% of the tuition will be due. The full tuition will be due should an intensive training course be cancelled within a week of the training's commencement. In the event of a cancellation of a group or individual session within a week of the first single lesson, the full tuition will be due. The postponement or cancellation of an individual session will be without charge, provided that the training provider is informed of such postponement or cancellation at least 48 hours prior to the session's commencement, and that such session is made up within three months of the end of the agreed upon language training. Individual sessions on Mondays can be postponed by twelve o'clock on the previous Friday. In the case of a group training course, a refund of course fees for the time absent is hereby expressly excluded. A refund of course fees for the time absent or early registration is hereby expressly excluded.

#### § 4 OFFERS AND PRICES

All offers and prices are non-binding. They may be adjusted without prior notice to the factual conditions and the changed costs. Payment terms, cash discounts or other deductions will not be granted, unless agreed in writing. If the minimum number of participants in group training is below requirement, we reserve the right to make a flexible adjustment of lesson units.

#### § 5 DATA PROTECTION

The customer acknowledges that his/her data will be stored and used in accordance with the German Data Protection Act, and that he/she will receive further information and advertising material regarding the training provider by email, post or otherwise.

#### § 6 NON-COMPETITION CLAUSE

The customer expressly agrees that all terms in relation to course times, content, duration, tuition and expenses are to be agreed solely with the training provider and not with an individual trainer. The customer hereby agrees not to independently engage trainers who have become known to the customer through the language provider, but rather, for the duration of the co-operation as well as up to a year afterwards, to order training solely through the training provider. The customer will inform the training provider of any case in which a trainer offers training to the customer on an independent basis. The use of any documents relating to the training provider in courses not arranged or held by the training provider school is strictly prohibited.

#### § 7 DAMAGES AND FORCE MAJEURE; LIABILITIES AND COMPLAINTS

Any delay in performance or non-performance of any obligations and duties of the training provider will not be considered a breach if such delay or non-performance

is caused by an event beyond the training provider's control. Events beyond the training provider's control will include, but are not limited to, natural disasters, government action or inaction, strike or labour trouble, traffic disruptions or delays, interruptions in telecommunication or internet-related systems, war, acts of terrorism, fire or other casualty, unusually severe weather, absences of our staff or the like. Any and all liability for damage relating to viruses, trojans, auto-dialers, spam mail or similar disruptions caused by data are hereby expressly excluded. In no event will the training provider be liable for any consequential, indirect, exemplary, special or incidental damages, including without limitation any lost revenue or lost profits. The training provider's total cumulative liability in connection with any registration or order for training, whether in contract, tort or otherwise, will not exceed twice the invoice amount, up to a maximum of five thousand euros, in cases of negligence and three times the invoice amount, up to a maximum of ten thousand euros, in cases of intentional misconduct and gross negligence. Complaints relating to trainers or the content of the training shall be made during the duration of language training. The customer is obligated to inform the training provider in writing, as early as possible during the duration of the language training, about any difficulties or problems in relation to the language training. The training provider may disregard complaints received after completion of the language training. In case of justified complaints, the training institute maintains the right to change the trainer multiple times. The customer will remain obliged to accept the services provided and make the payments accordingly.

#### § 8 ASSIGNMENT

The customer may not assign or transfer any of his/her rights under this contract to any third party without the training provider's prior written consent.

#### § 9 CHANGES TO THE TERMS AND CONDITIONS OF LANGUAGE COURSE PARTICIPATION

Changes can be made at short notice to the Terms & Conditions. The customer may contact the training provider at any time if a copy of the current Terms & Conditions is desired.

#### § 10 Final Clauses

By registering, the customer explicitly acknowledges the Terms & Conditions as an integral part of the contract. The invalidity of one of the conditions of the agreement does not result in the invalidity of the entire agreement or all of the conditions; the parties to the agreement commit to replacing an invalid condition with a valid one, which corresponds most closely to the invalid condition according to economic content. The place of jurisdiction for both parties is Frankfurt am Main.
